BLR Policies for Contracting Dr. Shuler's Motivational Services:

- I. Authority: This Motivational Speech is under the auspices of BLR: Building Lasting Relationships.**
- II. Fee: The minimum honorarium for this Motivational Speech is \$1,000.00.**

Pre-registration is beneficial because:

1. **People value events in which they have a personal investment.**
2. People, especially men are less likely to change their minds, even if the weather is good for golf or fishing, or fear of the conference, if they have already invested financially;
3. This method protects the church budget.
4. All of the previously mentioned reasons **results in higher attendance.**

BLR is *flexible* and *reasonably negotiates* with those in areas unable to meet this honorarium. If unable to secure this fee, please call Clarence so he and your organization can work out a solution to get Clarence in front of your group to motivate them.

- III. Transportation:** The host organization is financially responsible for the airfare and for any expenses incurred coming to or returning from this event for Dr. Shuler, including parking at the Colorado Springs Airport.

Dr. Shuler **only** flies **United Airlines** unless United doesn't fly to your location. The reason being that their frequent flyer status with United, provides him with viable options whenever weather and/or mechanical problems affect his flight either in route or returning home, which he doesn't have with other airlines.

- IV. Lodging & Meals:** The host organization is financially responsible for Dr. Shuler's hotel accommodations and meals for Dr. Shuler for duration of his event stay which includes Saturday evening and Sunday if Dr. Shuler is asked to stay over to preach on Sunday.

- V. Deposit:** Previously, experience forces BLR to operate in a strict business manner regarding bookings and fees for its services. BLR contracts on a "first come, first serve" basis. BLR naturally refuses other engagements on this confirmed date. BLR desires to do ministry. If a seminar is canceled, it is often too late to book one of the churches/organizations previously refused due its "first come, first serve" policy.

Therefore, after much prayer, a **Building Lasting Relationships' Motivational Speech event requires a \$500 non-refundable deposit. This deposit must be received within three weeks after a mutually agreed upon date is set. Failure to receive said deposit within stated time releases Building Lasting Relationships from any verbal and/or written contract.**

VI. Booking: Event may be booked up to two years in advance or a minimum of two weeks notice.

VII. Materials Required for this Motivational Speech: Large projection screen, DVD player & internet access.

VIII. Selling Books: BLR requests permission to sale any books and DVDs produced by Dr. Shuler. BLR also requests assistance in selling these resources. Resources would be sold before event begins and at conclusion of event. **Books Signings** are welcome.

IX. Recording and/or Videoing: No part of this Motivational Speech may be reproduced **without written permission** from BLR: Building Lasting Relationships. Permission **must be secured 7 business days before** event. If permission is granted, BLR shall receive **65 percent** of the profit on day of event and all future profit from sales from reproduction of BLR seminar (CDs, DVDs, etc.). BLR is to receive unlimited copies of these resources upon request.

X. Contract: We, the organization (s), etc. accept all of the terms of this contract stipulated by **BLR: Building Lasting Relationships** understanding that if our organization should cancel for any reason after a date has been agreed upon by both host organization (s) and **BLR: Building Lasting Relationships**. **BLR requires a \$500 non-refundable deposit. This deposit must be received within three weeks after a mutually agreed upon date has been set. Failure to receive said deposit within stated time releases Building Lasting Relationships from any verbal and/or written contract.** We, the organization (s), **forfeit(s) the \$500 deposit.** If the event is held, the **\$500 balance of the motivational speech fee is due at the conclusion of and at the site of event.**
